Choose you hunt choices and indicate them on the application form. Please mark below from 1 – 3 your hunt choices. Wilderness, late rifle, muzzle loader and early bow hunts are the easiest hunts to draw. If you are not successful in the draw your license fee excluding a six dollar application fee will be refunded to you. These are trophy quality areas and we recommend that you keep applying until a tag is drawn. All hunts are subject to NM state tax (6.875%). A 50% deposit is required to book landowner tags and private land tags. A 50% deposit is required when you draw a tag. All deposits are non-refundable. Final payments are due 30 days prior to the start of the hunt. Please make all deposits, license fees, and final payments payable to Frontier Outfitting.
